## **About Us**

#### **Aims and Objectives**

Our mission is to provide free family legal advice and support to those experiencing domestic abuse, with the aim of empowering individuals to rebuild their lives. We work to raise awareness of legal rights and collaborate with other organisations and government agencies to 'ensure access to appropriate resources to enable our clients to make better informed choices towards escaping abuse.



To achieve our aims we:

- Establish a network of trained legal professionals to provide free, confidential family law advice to domestic abuse victims
- Raise awareness of people's legal rights and the legal process
- Work with local resources and organisations to strengthen networking and relationships
- Advocate for policy changes and legal reforms that protect domestic abuse victims' rights

## Our Story So Far

Located in Newbury, Berkshire, FLAG DV serves those experiencing domestic abuse in Thames Valley and Hampshire. Our service is available to anyone, regardless of gender, ethnicity, religion, or sexual orientation.

In October 2023 we will mark our 10 th anniversary. Flag DV was established in direct response to the legal aid changes that took place in 2013 and introduced additional barrier for victims of domestic abuse.

We provide free legal advice and support to empower individuals experiencing domestic abuse to make informed decisions about their situation. Our approach is non-judgmental, we believe in providing a safe and open space for clients at any stage of their journey and we support their choices at the time they seek our advice.

For some it is about gaining an understanding of the steps they need to take before leaving an abusive relationship and to understand the challenges they may face in order to prioritise their next steps. For others, it is about navigating the ongoing challenges of uncoupling from a manipulative and controlling partner, including child custody and family court proceedings, as well as seeking advice around protection orders, divorce, and separation.

Our aim is to support them with legal options and empower them to make informed decisions about their future.

## Message From Our CEO

As I reflect on my first year as FLAG DV's chief executive, I'm incredibly proud of what our small charity has achieved in response to the pandemic and the subsequent cost of living crisis.

Despite a 44% year on year increase in referral demand, our staff and volunteers worked hard to maintain our service delivery, keeping the wait time for an appointment as low as possible, despite the strain on resources.

Our work is only possible thanks to the support of our donors, volunteers, and staff. Thank you for standing with us in our mission to make a difference in the lives of people experiencing domestic abuse.


